

Notice of Special Election

In accordance with 25 P.S. §§ 2787, 2866, and 3041 of the Pennsylvania Election Code, notice is hereby given of a Special Election to be held in 41 precincts in Northumberland County to fill a vacancy in the office of Representative in Congress in the 12th Congressional District. The Special Election will be held concurrently with the normally scheduled May 21, 2019 Municipal Primary between the hours of 7:00 AM and 8:00 PM prevailing time.

ALL registered voters in the 12th Congressional District in Northumberland County will be eligible to cast a ballot on May 21 regardless of their party affiliation on their voter registration record.

Voters who are registered with the Democratic or Republican parties will be eligible to vote on their respective party primary ballots to select party nominees to appear on the November ballot. They will also be eligible to vote in the special election to elect a Representative in Congress.

Voters who are registered with all other political parties (Green, Independent, Libertarian, etc.) will be eligible to vote in the special election to elect a Representative in Congress.

All of Bradford, Clinton, Juniata, Lycoming, Mifflin, Perry, Potter, Snyder, Sullivan, Susquehanna, Tioga, Union, and Wyoming Counties; and parts of Center and Northumberland Counties.
