Mr. Skavery reported that he has been unable to contact this individual by phone and/or certified letters. Mike Thomas suggested that Mr. Skavery request his intent in writing within 30-60 days of his intent to do land development.

New Business:

- Troy Laudenslager, Mahantonga Game Farms/Jordan Twp. Mr. Laudenslager gave an overview of his project. The site is 129 acres physically under netting. The farm raises game birds and the project is in the center of the farm. The pens have been in that location for about 21 yrs. and the pen's life expectancy is typically about 20 yrs. until the nets and posts need to be replace. In their current process of moving/rebuilding pens they were questioned about land disturbance. Mr. Laudenslager is here for informational purposes and how to move forward. Mike Thomas reported that his interpretation is that it is considered to be land development by SALDO definition. The game farm is in the process of working with Conservation District and getting a NPDES permit. Mr.Laudenslager is advised to address this matter again with Planning Commission after his meeting with the Conservation District and DEP for the NPDES. Mr.Skavery anticipates attending said meeting as well.
- Point Township is amending their SALDO as noted in Mr. Skavery's comments that were emailed earlier.
